TOWN OF SPRINGFIELD PUBLIC OPINION SURVEY

The Town of Springfield is beginning a process to update the Town's Comprehensive (Land Use) Plan, which will help guide the pace, type, and appearance of growth and development over the next 20 years. Once completed, the Plan will include recommendations for land use, farmland preservation, transportation, environmental protection, and economic development. Planning for the impacts of the Highway 12 expansion project will be a key component of this effort.

The information we obtain from you will be combined with other participation efforts to create the new Comprehensive Plan. Your input is extremely important; it will help the Town prepare a Comprehensive Plan that reflects the goals, values, and wishes of its citizens.

For the past several years, local and County officials have been discussing the possibility of a new highway around the north side of Lake Mendota. That highway has been referred to by various names, including “North Beltline”, “North Ring Highway”, and “Mendota Parkway.” Preliminary plans suggest that it would generally follow the alignment of County Highway K in the Springfield area, but would require the upgrading and/or relocation of the existing roadway.

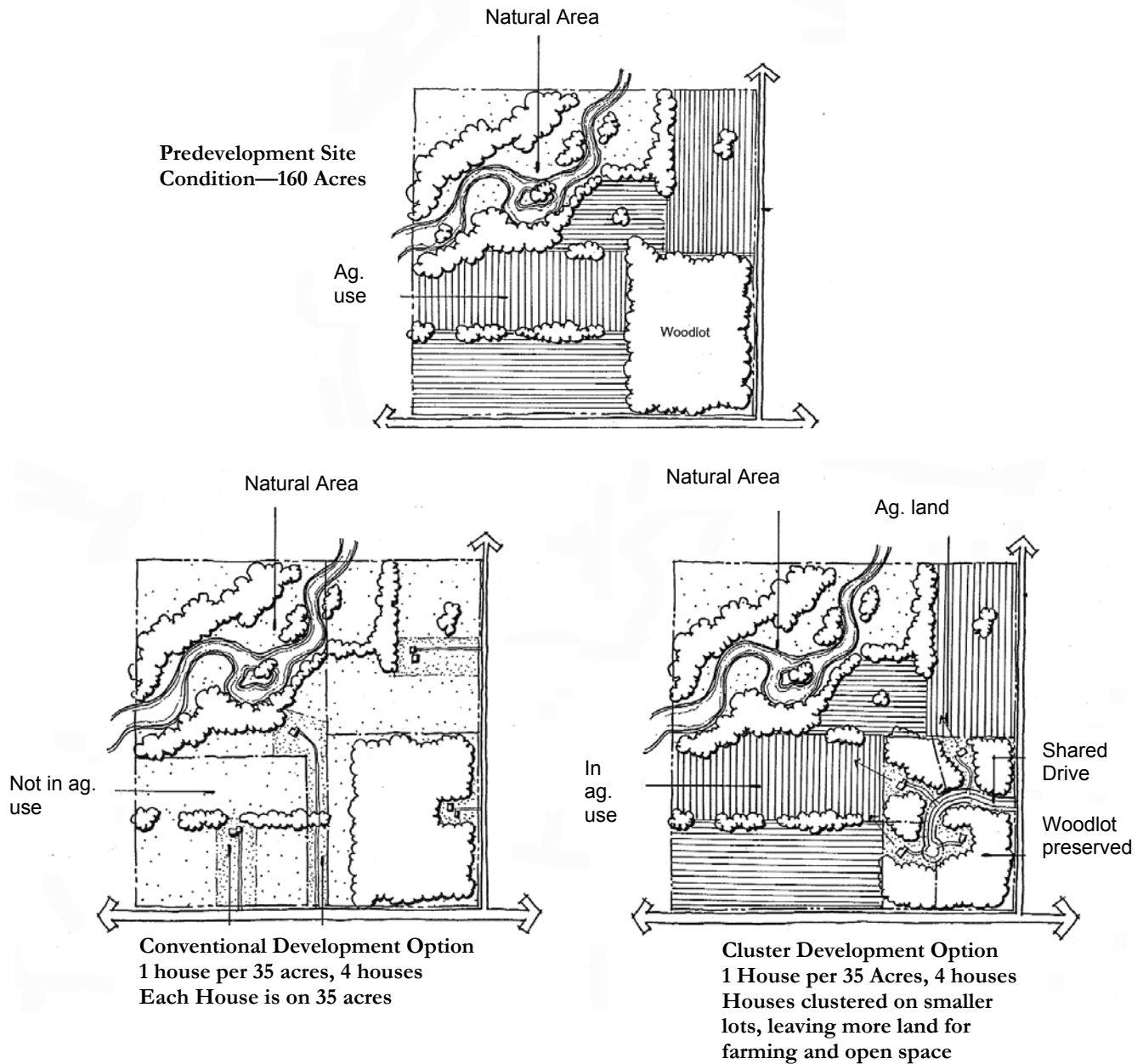

In a “cluster development,” residential lots may be smaller than usual and/or grouped closer together than in conventional development patterns. The purpose of this type of development is to retain larger areas of agricultural land and open space than would normally be left after development. The preservation of these areas allows agricultural uses to continue, and wetlands and other environmentally sensitive areas to remain intact, preserving their function as wildlife habitats, environmental buffers between land uses, and natural stormwater management systems. The following is an illustration of a hypothetical 160-acre parcel developed in the conventional manner, compared to a cluster development.
