As Dane County faces the potential of being out of compliance with federal environmental standards for air quality, the county should take steps to embrace the use of alternative energy and other sustainable practices. This amendment creates a \$100,000 fund to supplement department budgets for capital projects to maximize sustainability and achieve long term savings for the county. Examples of projects appropriate for use of the fund include: differential costs for converting fleet vehicles to alternate fuel or other high efficiency vehicles, a digester for converting waste from the Vilas Zoo to energy, or an efficiency study to identify alternative energy options for the Alliant Energy Center.
