The following information becomes part of Bid #105114:

1. All chains should be metal bead, not plastic bead.
2. Pricing for the Mecho shades should include the fascia.
3. No valences are required for the Levolor mini blinds.
4. Chains should be free hanging, not fastened to the window frames or walls.
5. Levolor blinds should be: Riviera Classic Contract DustGuard 1" Blinds, 8 gauge. The equivalent Bali Classics Mini Blind will also be accepted. County will select from manufacturer's standard color palate.
6. Mecho shade fabric shall be ThermoVeil Vertical Weave 0900 Series. County will select from manufacturer's standard color palate.
7. Mecho room darkening shade fabric shall be Blakcout Series 0700. County will select from manufacturer's standard color palate. Room darkening shades in the Jury Assembly room do not require side channels. Room darkening shades in the Media Viewing area and FCCS Observation do require side channels.
