SUBJECT: [Request for Proposal \(RFP\) #110100 Interoperable Voice Radio Communication System](#)

The following addendum becomes a part of the above referenced RFP. All other terms and conditions remain in effect, unchanged.

- A. Changes to Specifications: The following requirements have been changed as follows:
- Special Instructions [Cover page of RFP]: The third bulleted item in the Special Instructions shall be stricken as it is written and replaced with the following bulleted item:
“ Submit one original and 10 copies of your technical proposal”
 - Section 5.8.12: The following sentence shall be added to the end of the existing text of Section 5.8.12: “Proposers shall specify the logging recorders (by vendor and model name) supported by their proposed interface and they shall specify the level to which they have tested the interface(s) (verified, certified, etc) as well as the level of support they provide for the interface(s).”
 - The following text shall be added as a second paragraph to the existing text of Section 6.1.3: “The County intends score the cost proposals in the following manner:
 - Costs will be divided into three categories: i) initial capital, ii) the capitalized cost of years 0 – 5 of operations/maintenance (to include years 2012 (the first year of operation) and years 2013-2017), and iii) the capitalized cost of years 6 - 10 of operations/maintenance.
 - Of the 30 cost criteria points available, 15 will be assigned to the initial capital costs, 10 will be assigned to the capitalized cost of years 0 - 5 of operations/maintenance, and 5 will be assigned to the capitalized cost of the years 6 – 10 of operations/maintenance.
 - Each category will be scored independently per the method described in Section 6.1.2 of this RFP.
 - The capitalized costs of leased sites, as described in the addition to Section 6.5.1 that was included in Addendum #2, will be included in the category of initial capital.

- B. Revised Costing Sheets: Concurrent with the release of this Addendum #3, revised costing sheets will be posted at www.danepurchasing.com. These sheets are to be used by vendors when responding to this RFP and they shall replace the previously-posted version of the costing sheets.
